Proposals must be accompanied by the following where applicable:-

- (i) Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) Valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original and five (5) copies each of the Technical and Financial Proposals should be submitted in separate sealed envelopes and clearly marked on the outside:-

The Technical Proposals will be opened shortly thereafter. The Consultant or a representative may be present at the opening.
