The Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) for the Project, *Strengthening of the Single Electronic Window for Trade and Business Facilitation*. Funding received for the project shall be applied to the above mentioned Consultancy.

The Scope of Services for the Consultancy is to develop and implement an integrated risk management system for use by the Customs and Excise Division and other Ministries and Agencies in conformance with the World Customs Organization (WCO) Risk Management Compendium. The system must be robust enough to identify sources of information, define data collection principles, cross-reference, evaluate; process and validate data and intelligence in a mainly computerized environment.

In this regard, the Central Tenders Board (CTB), on behalf of the Executing Agency, the Ministry of Trade and Industry (MTI), invites eligible Consulting Firm(s) to indicate their interest in providing the Consulting Services. Interested firm(s) must provide information to substantiate their ability to perform the Consulting Services. Submissions must include, at a minimum, a company profile inclusive of a signed transmittal letter and project summary of experience in similar projects (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills amongst staff, financial capability, etc.)

This Consultancy requires Consulting Firm(s) to have the specific experience and/or capabilities and must substantiate such in the following areas:-

- (i) developing and implementing risk management systems in a customs/port environment.
- (ii) institutional development within customs and other public sector agencies in the context of trade facilitation and the international supply chain.

(iii) the ability to work with multiple agencies in a complex project environment to attain interoperability for the single electronic window.
