The Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) for the Project, *Strengthening of the Single Electronic Window for Trade and Business Facilitation*. Funding received for the project shall be applied to the above mentioned Consultancy.

The Scope of Services for the Consultancy is to develop and implement an automated system for submission and processing of applications for construction permits spanning multiple government agencies. The Consultancy must modernize, simplify and streamline the process to obtain construction permits thus reducing the application transaction time, number of process and costs to obtain construction permits in Trinidad and Tobago.

In this regard, the Central Tenders Board (CTB), on behalf of the Executing Agency, the Ministry of Trade and Industry (MTI), invites eligible Consulting Firm(s) to indicate their interest in providing the Consulting Services. Interested firm(s) must provide information to substantiate their ability to perform the Consulting Services. Submissions must include, at a minimum, a company's profile inclusive of a signed transmittal letter clearly indicating the nationality of the firm and project summary of experience in similar projects (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills amongst staff, financial capability, etc.)

This Consultancy requires Consulting Firm(s) to have the specific experience and/or capabilities and must substantiate such in the following areas:-

- (i) developing and implementing an automated system for construction permits
- (ii) technical capacity in international best practice in automation of construction permit systems in government services and public sector reform

(iii) the ability to work with multiple agencies in a complex project environment to attain seamless integration and interoperability with the e-Government infrastructure and all relevant stakeholders' database systems.
