Tenders are invited for the Supply and Delivery of One (1) Heavy Duty Wrecker to the Trinidad and Tobago Fire Service, Ministry of National Security.

- (a) **Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of tender.**
- (b) **Certificate of Compliance issued in accordance with the National Insurance Act.**

Tenders on the approved tender form (**IN TRIPLICATE**) should be placed in sealed envelopes clearly marked on the outside:-

Late tenders **will not** be considered in any circumstances.
