Tender for the Construction of a Pavilion at the Ste Madeleine Recreation Ground for the Princes Town Regional Corporation, Ministry of Local Government

Tenders are invited for the construction of a Pavilion at the Ste. Madeleine Recreation Ground for the Princes Town Regional Corporation, Ministry of Local Government.

Tender documents may be obtained during normal working hours at the Central Tenders Board's Office, 116 Frederick Street, Port of Spain.

Any further technical information may be obtained during normal working hours from Ms. Vida Toodesh, Engineering and Survey Officer, Princes Town Regional Corporation at telephone numbers 655-2416/2417 and 2239.

Tenderers are required to pay a tender deposit of Five Hundred Dollars (\$500.00) payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116 Frederick Street, Port of Spain. This deposit will be received from Monday to Friday between the hours of 9.00 a.m. to 12:00 noon and 1:00 p.m. to 3:00 p.m. The original receipt must be attached to the tender.

A pre-tender meeting followed by a site visit will be held for prospective tenderers at 11:00 a.m. on Monday August 13, 2012 at the Corporation's Hall, Princes Town Regional Corporation, Hoseins Mall, High Street, Princes Town.

Tenders must be accompanied by the following:

- (i) Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of tender.
- (ii) Valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original and three (3) copies of the tender should be placed in sealed envelopes clearly marked on the outside:

“Tender for the Construction of a Pavilion at the Ste Madeleine Recreation Ground for the Princes Town Regional Corporation, Ministry of Local Government”

The envelopes must be addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and must be deposited in the **BROWN** Tenders Box located in the lobby of the Board's Office not later than **1:00 p.m. on Thursday August 23, 2012.**

Tenderers should note that the dimensions of the slot in the Tenders Box are **37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Tenders will be opened shortly thereafter. The tenderer or his representative may be present at the opening.

Late tenders will **NOT** be considered in any circumstances.

The Board does not bind itself to accept the lowest or any other tender.

The Central Tenders Board reserves the right to cancel the present notice in its entirety or even partially, without defraying any cost incurred by any firm, in submitting their tender.
