Tenders are invited for the supply and delivery of Vehicles to the Trinidad and Tobago Defence Force (Defence Force Headquarters), Ministry of National Security as follows:-

- Item 1 - One (1) Station Wagon
- Item 2 - Ten (10) Light Trucks
- Item 3 - Two (2) Panel Vans
- Item 4 - One (1) Box Truck

- (ii) Valid Certificate of Compliance issued in accordance with the National Insurance Act.
