Tenders are invited from suitably qualified and experienced contractors for the Richplain Ravine Improvement Works Phase II for the Drainage Division, Ministry of Works and Transport.

Tender documents may be collected during normal working hours at the Central Tenders Board - 116 Frederick Street, Port of Spain. Interested contractors are required to pay a tender deposit of one thousand dollars (\$1,000.00 TT) payable by cash or certified cheque to the Director of Contracts and attach the original receipt to their tender. This tender deposit will be received from **Monday to Friday between the hours of 8:30 a.m. to 12.00 noon and 1:00 p.m. to 2:00 p.m.**

A pre tender meeting will held at **10:00 a.m. on 9th April, 2008** in the Conference Room of the Drainage Division, 41-43 Sackville Street, Port of Spain and this will be followed by the site visit.

Tenders must be accompanied by the following:-

- (a) Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue dated not more than six (6) months prior to the closing date of the tender:**
- (b) Up-to-date certificate of Compliance issued in accordance with the National Insurance Act.**

Tenderers are required to submit their tender using two the (2) envelope system.

One (1) original and two (2) copies each of the technical and financial submission will be received up to **1:00 p.m. on Thursday 17th April, 2008**. The envelopes must be addressed to the Chairman, Central Tenders Board and clearly marked on the outside:-

Tenderers are asked to note that the dimensions of the **slot** of the Tenders Box are **37.5 cm x 5.5 cm**. Tenders should therefore be packaged accordingly.

Envelope No I (Technical Submission) will be opened shortly thereafter. Envelope No 2 (Financial Submission) of qualified tenderers only will be opened and evaluated after the Technical Evaluation. The tenderer or his representative may be present at the opening.

Late tenders will not be considered under any circumstances.

The Board does not bind itself to accept the lowest or any other tender.

The Central Tenders Board reserves the right to cancel the present Notice in its entirety or even partially, without defraying any cost incurred by any contract in submitting his tender.
