Tender for Road Paving Works for the Sangre Grande Regional Corporation, Ministry of Local Government

Tenders are invited for Road Paving Works on the under-mentioned six (6) roads for the Sangre Grande Regional Corporation, Ministry of Local Government: -

1. Teak Lane/Cicada Drive, Valencia
2. Tamana Section II Road, Tamana
3. Old Plum Road, Plum Mitan
4. Rousseau Road, Guaico
5. Wine Factory Road, La Seiva
6. Providence Street, Sangre Grande

Tenderers are required to pay a tender deposit of five hundred dollars (**\$500.00**) payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116 Frederick Street, Port of Spain. This deposit will be received from Monday to Friday between the hours of **9.00 a.m. to 12.00 noon and 1.00 p.m. to 3.00 p.m.** The original receipt must be attached to the tender.

A pre-tender meeting followed by a site visit will be held for prospective tenderers at **10.00 a.m. on Tuesday 28th June, 2011** at the Sangre Grande Regional Corporation, Ramdass Street, Sangre Grande.

Separate contracts may be awarded for each road or a combination of roads.

Tenders must be accompanied by the following:

- (i) Valid Income Tax and Valued Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) A Valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original Tender Document and two (2) copies of the Form of Tender and Bill of Quantities must be placed in a sealed envelope, addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain, clearly marked on the outside: -

The envelope must be deposited in the **BROWN** Tenders Box, located in the lobby of the Board’s Office not later than **1:00 p.m. on THURSDAY 14th JULY, 2011.**

Tenderers should note that the dimensions of the slot of the Tenders Box are **37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Tenders will be opened shortly thereafter. The tenderer or his representative may be present at the opening.

The Central Tenders Board reserves the right to cancel the present notice in its entirety or even partially, without defraying any cost incurred by any firm in submitting their tender.

Late tenders will not be considered in any circumstances.

The Board does not bind itself to accept the lowest or any other tender.
