Tenders are invited for the Rehabilitation of Roads and Bridges for the Arima Borough Corporation, Ministry of Local Government at the following locations: -

- Project 1 - Egbert and Alleyne Street, Arima North East
- Project 2 - Seejagath Trace, Tumpuna
- Project 3 - Town Centre Pavement, Arima North East
- Project 4 - Malabar Main Road - Gooding Street, Arima West Central

**Only one project will be awarded per contractor.**

Tenderers are required to pay a tender deposit of five hundred dollars (**\$500.00**) to the Director of Contracts, Central Tenders Board and **attached the original receipt** to the tender. This deposit will be received by cash or certified cheque from Monday to Friday between the hours of **9.00 a.m. to 12.00 noon and 1.00 p.m. to 3.00 p.m.**

A pre-tender meeting followed by site visits will be held for prospective tenderers on **Tuesday 9<sup>th</sup> August, 2011 at 9.30 a.m.** at the Arima Town Hall, Sorzano Street, Arima.

Tenders must be accompanied by the following:

- (i) **Valid Income Tax and Valued Added Tax Clearance Certificates** issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) **A Valid Certificate of Compliance** issued in accordance with the National Insurance Act.

The original Tender and two (2) copies each of the Form of Tender and Bill of Quantities must be placed in a sealed envelope, addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain, clearly marked on the outside: -

**“Tender for the Rehabilitation of Roads and Bridges for the Arima Borough Corporation, Ministry of Local Government”**

Envelopes must be deposited in the **BROWN** Tenders Box, located in the lobby of the Board’s Office not later than **1:00 p.m. on THURSDAY 18<sup>th</sup> AUGUST, 2011.**

Tenderers are asked to note that the dimensions of the **SLOT** of the Tenders Box are **37.5 cm x 5.5 cm** and tenders should be packaged accordingly.

Tenders will be opened shortly thereafter. The tenderer or his representative may be present at the opening.

**Late tenders will not be considered in any circumstances.**

The Board does not bind itself to accept the lowest or any other tender.

The Central Tenders Board reserves the right to cancel the bidding process in its entirety or even partially, without defraying any cost incurred by any firm in submitting their tender.
