Tenders are invited for the supply and delivery of vehicles to the Port of Spain Corporation, Ministry of Local Government as follows:-

1. One (1) Four Wheel Drive Utility Vehicle
2. Two (2) Double Cab 4x4 Light Truck

- (ii) Valid Certificate of Compliance issued in accordance with the National Insurance Act.
