Tenders are invited for the supply and delivery of Vehicles/Mechanical Equipment to the Arima Borough Corporation, Ministry of Local Government as follows:-

Item 1 – One (1) 4x4 Double Cab Pick-Up Vehicle

Item 2 – One (1) 4x4 Sports Utility Vehicle

Item 3 – One (1) Mini Backhoe Loader

Item 4 – One (1) Forklift

- (ii) Certificate of Compliance issued in accordance with the National Insurance Act.

Tenders on the approved tender forms (IN DUPLICATE), should be placed in sealed envelopes clearly marked on the outside:-

Late tenders **will not** be considered in any circumstances.
