A pre-tender meeting for prospective tenderers will be held on <u>Thursday August 26, 2010 at</u> <u>10.00 a.m.</u> at the San Juan/Laventille Regional Corporation, and thereafter all persons present would be invited to proceed to the sites.

Tenders must be accompanied by valid:-

- (i) **Income Tax and Valued Added Tax Clearance Certificates** issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) Certificate of Compliance issued in accordance with the National Insurance Act.
