Tender for Road Paving Works for the Princes Town Regional Corporation, Ministry of Local Government

Tenders are invited for Road Paving Works on the under-mentioned five (5) roads for the Princes Town Regional Corporation, Ministry of Local Government:-

- (i) Seegoolam Avenue - Off Naparima/Mayaro Road - 450m x 4.2m x 62.5mm
- (ii) Mairo 6th Avenue - Off the Naparima/Mayaro Road - 450m x 4.2m x 0.062m
- (iii) Loney Road - Off Moruga Road, Indian Walk Village, - 396m x 5.2m x 62.5mm
- (iv) Fairfield Road - Off Naparima/Mayaro Road - 458m x 6.1m x 62.5mm
- (v) School Trace - Off Naparima/Mayaro Road - 600m x 0.5m x 62.5mm

Tenderers are required to pay a tender deposit of **five hundred dollars (TT\$500.00)** payable by cash or certified cheque to the Director of Contracts. Payment can be made from 9.00 a.m. to 12.00 noon and from 1.00 p.m. to 3.00 p.m. Monday to Friday at the Central Tenders Board's Office. The original receipt should be attached to the tender documents.

A **pre-tender meeting** for prospective tenderers will be held on **Thursday September 01, 2010 at 9.00 a.m.** at the Princes Town Regional Corporation and thereafter all persons present would be invited to proceed to the sites.

Tenders must be accompanied by valid:

- (i) **Income Tax and Valued Added Tax Clearance Certificates** issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) **Certificate of Compliance** issued in accordance with the National Insurance Act.

The original tender document together with one (1) copy each of the Form of Tender and Bill of Quantities must be placed in a sealed envelope and addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and clearly marked on the outside:-

Regional Corporation, Ministry of Local Government”**

Envelopes must be deposited in the **BROWN** Tenders Box, located in the lobby of the Board’s Office not later than **1:00 p.m. on THURSDAY SEPTEMBER 09, 2010.**

Tenders will be opened shortly thereafter. The tenderer or a representative may be present at the opening.

Tenderers should note that the dimensions of the **SLOT** in the Tenders Box are **37.5 cm x 5.5 cm** and as such tenders should therefore be packaged accordingly.

Late tenders will not be considered in any circumstances.

The Board does not bind itself to accept the lowest or any other tender.

The Central Tenders Board reserves the right to cancel the present notice in its entirety or even partially, without defraying any cost incurred by any firm, in submitting their tender.
