Tenderers are required to pay a tender deposit of **Five Hundred Dollars (\$500.00)** payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116 Frederick Street, Port of Spain. This deposit will be received from Monday to Friday between the hours of **9.00 a.m. to 12:00 noon and 1:00p.m. to 3:00 p.m.** The **original** receipt must be attached to the tender.

A pre-tender meeting to be followed by site visits will be held for prospective tenderers on **MONDAY, MARCH, 16<sup>TH</sup>, 2011** at **10:00 a.m.** at the Chaguanas Borough Corporation, Corner Taitt and Cumberbatch Streets, Chaguanas.

Tenders **must** be accompanied by:-

- (i) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing of the tender.
- (ii) valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original Tender Document and two (2) copies each of the Form of Tender, Bills of Quantities and Summary Sheets must be placed in a sealed envelope and addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and clearly marked on the outside:-
