Prospective tenderers are asked to visit the site in order to acquaint themselves with conditions, which may influence their tender. Visits are scheduled for **December 17, 2007 to December 20, 2007.**

**Request for visits other than the days listed will not be considered.**

**Contracts will be awarded on the basis of one (1) project per contractor.**

Tenders must be accompanied by the following:

- (i) **Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of tender.**
- (ii) **Certificate of Compliance issued in accordance with the National Insurance Act.**
