Tenders are invited for the construction of a Pavilion at Mount Pleasant Recreational Facility for the Division of Infrastructure and Public Utilities of the Tobago House of Assembly.

Tender documents are available during normal working hours at the Central Tenders Board's Office, 116, Frederick Street, Port of Spain. Tenderers are required to pay a tender deposit of **One Thousand Dollars (\$1,000.00)** payable by cash or certified cheque to the Director of Contracts, Central Tenders Board. This deposit will be received from Monday to Friday between the hours at **9:00 a.m. to 12:00 noon and 1:00 p.m. to 3:00 p.m.** The original receipt must be attached to the tender. Tenderers are also required to provide a bid security in the amount of **Two Hundred Thousand Dollars (\$200,000.00)** with their tender.

A pre-tender meeting to be followed by a site visit will be held for prospective tenderers on **Monday March 28<sup>th</sup>, 2011 at 10:00 a.m.** at the **Division Infrastructure and Public Utilities of the Tobago House of Assembly, Old Government Farm Road, Downtown, Scarborough, Tobago.**

Tenders must be accompanied by valid:

- (i) Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) Certificate of Compliance issued in accordance with the National Insurance Act.

The original Tender Document and two (2) copies each of the Form of Tender and Bills of Quantities must be placed in sealed envelopes and addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain clearly marked on the outside:

Envelopes must be deposited in the **BROWN** Tenders Box located in the lobby of the Board’s Office **not later than 1:00 pm. on Thursday April 14, 2011.**

Tenders will be opened shortly thereafter. The tenderer or a representative may be present at the opening.

Tenderers should note that the dimensions of the **slot** in the tenders Box **are 37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Late tenders will **NOT** be considered in any circumstances.

The Board does not bind itself to accept any tender.

The Central Tenders Board reserves the right to cancel the bidding process in its entirety or partially, without defraying any cost incurred by any firm in submitting their tender.
