Tenderers are required to pay a tender deposit of **One Thousand Dollars (\$1,000.00)** payable by cash or certified cheque to the Director of Contracts, Central Tenders Board. This deposit will be received from Monday to Friday between the hours of **9:00 a.m. to 12:00 noon and 1:00 p.m. to 3:00 p.m.** The original receipt must be attached to the tender. Prospective tenderers from Tobago are advised to contact Ms. Jan Thompson of the Division of Infrastructure and Public Utilities, Telephone No.687- 0000 to arrange for the collection of documents.

Tenderers are also required to provide a bid security in the amount of **Two Hundred Thousand Dollars (\$200,000.00)** with their tender.

A pre-tender meeting to be followed by a site visit will be held for prospective tenderers on **Wednesday May 25<sup>th</sup>, 2011 at 9:30 a.m.** at the **Division of Infrastructure and Public Utilities of the Tobago House of Assembly, Old Government Farm Road, Downtown, Scarborough, Tobago.**

Tenders must be accompanied by valid:

- (i) Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) Certificate of Compliance issued in accordance with the National Insurance Act.

The original Tender Document and two (2) copies each of the Form of Tender and Bills of Quantities must be placed in sealed envelopes and addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain clearly marked on the outside:
