SCAM ALERT!!

FINANCIAL INTELLIGENCE UNIT • MINISTRY OF FINANCE

The Financial Intelligence Unit of Trinidad and Tobago alerts the public of a continuing trend in 'scams' initiated primarily through the Internet. Scam techniques change constantly but retain one common feature – victims are led to believe that they have a chance to obtain a large financial benefit in return for a small up-front payment.

Some scams observed involve **FAKE lottery winnings, conferences, inherited wealth, business opportunities, internet romances, work permit assistance and job offers.**

Citizens of Trinidad and Tobago including senior citizens have fallen victims to these scams and have lost considerable sums.

STOP SENDING funds to persons you **DO NOT KNOW.**



STOP TRANSFERRING your 'hard earned funds' to persons you **DO NOT KNOW** located in countries abroad based on an email, a letter, a text message, a telephone call or social media contact.



Do not **OFFER** or give your bank account details to persons you do not know. This could be an attempt to use your account for illegal purposes.





e-TAX is the online portal provided by the Inland Revenue Division (IRD)



Filing your 2015 Tax Return is now faster, simpler and more convenient when you use **e-TAX**.



e-TAX provides Taxpayers with 24-hour access, the ability to track the status of your return and faster processing of your refund cheque.



Simply register online with ttconnect and you are on your way.

Registering with ttconnect

- Go online to www.ttconnect.gov.tt and complete the online registration for a ttconnect ID (for tax purposes).
- Activate your ttconnect ID online via your email. You will then receive online verification that your account has been successfully activated.
- Visit a ttconnect service centre most convenient to you with two forms of ID and verification of your BIR No. (i.e. Notice of Assessment, Advice of BIR, Statement of Account and Tax Clearance).

Filing the tax

- Gather tax documents to support your claims (e.g. TD4 slips, annuity & tertiary expenses statements etc.)
- Go online to www.ird.gov.tt or access e-tax from the ttconnect website at www.ttconnect.gov.tt
- Key in your ttconnect ID and password
- Create a Tax ID PIN (comprised of 4-6 digits)
- Check your e-mail to acknowledge receipt of Pin's confirmation (This verifies your e-mail address)
- Verify your account using either:
 - *A Letter ID No. from a recent BIR letter (ID is located on the top right hand corner of the letter)
 - *Your last return amount (refund/liability)
 - *Your last payment amount
- Log-in to e-tax with your tax ID Pin & use your tax documents to answer a few questions to complete the filing of the return.

Keeping you informed during a crisis



The Ministry of Finance recognises the importance of disseminating accurate and timely information to all its stakeholders including its employees during a crisis.

As such the Corporate Communications Unit, is developing the Ministry's first Crisis Communications Plan (CCP), which will provide the procedures for internal and external communications in the event of a crisis. The plan also intends to serve as a supplement for the Ministry's existing plan for Business Continuity.

A key aspect of the CCP is the establishment of a Crisis Communication Team (CCT) headed by the Permanent Secretary. To execute this plan, an emergency call tree will be developed for each department as an easy and effective way to notify staff of a crisis. The emergency call tree is a telecommunication chain that identifies which officer is responsible for notifying the respective staff members of a department.

The Corporate Communications Unit looks forward to the support of all for the successful completion of the Crisis Communication Plan, which will be of benefit to staff.
