Tenders are invited for the supply and delivery of Vehicles/Mechanical Equipment for the Trinidad and Tobago Defence Force (Regiment), Ministry of National Security as follows:

- Item 1 - Three (3) Ambulance
- Item 2 - Two (2) 10 Cubic Yards Dump Truck
- Item 3 - One (1) 4WD Backhoe Loader
