- Item 1 - Three (3) 4WD Double Cab Light Truck
- Item 2 - One (1) Thirty (30) Seater Passenger Bus
- Item 3 - One (1) Cargo Panel Van
- Item 4 - One (1) Cargo Box Type Truck (Straight Truck)
- Item 5 - One (15) Fifteen (15) Seater Bus

- (ii) Certificate of Compliance issued in accordance with the National Insurance Act.

Sealed tenders in **TRIPLICATE** on the approved Tender Form will be received not later than **1.00 pm on Thursday 12th June, 2014.**

Envelopes must be addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and must be deposited in the **BROWN** Tenders Box located in the lobby of the Board's Office.

Envelopes must be clearly marked:-
