Tenderers are required to pay a tender deposit of **Five Hundred Dollars (\$500.00)** payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116 Frederick Street, Port of Spain. This deposit will be received from Monday to Friday between the hours of **9.00 a.m. to 12.00 noon and 1:00 p.m. to 3:00 p.m.** The **original** receipt must be attached to the tender.

A pre-tender meeting followed by site visits will be held for prospective tenderers at **9:30 a.m.** on **Tuesday 1st September, 2015** in the Conference Room of the Chaguanas Borough Corporation, New Administrative Building, 154-164 Chaguanas Main Road, Chaguanas.

Tenders must be accompanied by the following:

- (i) **Valid Income Tax and Valued Added Tax Clearance Certificates** issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) **A Valid Certificate of Compliance** issued in accordance with the National Insurance Act.

The original and five (5) copies of the Tender should be placed in sealed envelopes, addressed to the **Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain** and clearly marked on the outside: -

Envelopes must be deposited in the **BROWN** Tenders Box, located in the lobby of the Board’s Office, 116 Frederick Street, Port of Spain, not later than **1:00 p.m.** on **THURSDAY 10th September, 2015.**

Tenders will be opened shortly thereafter. The tenderer or an authorized representative may be present at the opening.
