Applicants are invited from suitably qualified persons for appointment to the above-mentioned office.

Kind of Work

General duty police work to preserve peace, prevent and detect crime and other pertinent duties.

Application Forms

Applicants must bring **completed Application Forms** to the screening. Application forms are available from 8am to 3pm at all Municipal Corporations, Tobago House of Assembly and the Statutory Authorities Service Commission Department, 81-83 Abercromby Street, Port of Spain.

Basic Requirements:

- Valid Trinidad and Tobago Identification Card or a Valid Trinidad and Tobago Passport
- Valid Trinidad and Tobago Driver's Permit with Class 3 to drive light motor vehicles
- Trinidad and Tobago Electronic Birth Certificate
- 2 passport size photos
- Police Certificate of Character valid for the last 3 months or evidence of having applied for same
- Applicants should be no less than 18 and no older than 35 years of age on the 1st January of the year in which the appointment is made
- Males must be of good physique and at least 167 centimeters in height
- Females must be of good physique and at least 150 centimeters in height
- No visible tattoos

Educational Requirements

- Five (5) CXC subjects, General Proficiency, including English Language, Grades 1, 2 and 3; OR
- Five (5) subjects, Basic Proficiency, including English Language, Grade 1's ONLY; OR
- Five (5) G.C.E Ordinary Level passes, including English Language, Grades A, B and C.

Successful Applicants are required to:

- Write and pass the entrance examination
- Undergo a medical examination, agility test, psychometric test, drug test, polygraph test, background check and an interview

DRESS CODE: Applicants must be dressed in business attire: Male applicants to wear short sleeve shirts, dress pants and dress shoes/ Female applicants to wear short sleeve shirts/blouses, skirts below knee and dress shoes.

Applicants are reminded to bring with them the completed application form and the original and copies of all documents, including educational requirements as outlined, Driver's Permit, ID card, Passport, Electronic Birth Certificate and two (2) Passport sized pictures.

Persons who are holders of educational certificates other than CXC and GCE should have those qualifications assessed by the Ministry of Education. Persons who are holders of tertiary level education are to have the same evaluated by the Accreditation Council of Trinidad and Tobago.
