The Honourable Colm Imbert, Minister of Finance took great pride in officially launching two of four mobile container scanners (which were donated by the US Government) at the Port of Point Lisas on April 18th, 2018. The other two scanners will be deployed at the Port of Port of Spain at a later date.

Minister Imbert personally described the deployment of the scanners as **"a reflection of the long- standing, well-established and forward-moving partnership between the** U.S. Customs and Border Protection (CBP) **and the Government of the Republic of Trinidad and Tobago."** Indeed, the launch marked a new era of trade facilitation and border security for Trinidad and Tobago. Here is a summary of the main benefits as described by Minister Imbert in his feature address at the launch:

1. Border protection and Security.

Violent crime has a negative effect on T&T's landscape and mobile scanning is focused on combatting the importation of all contraband, specifically narcotics, illegal firearms and ammunition.

2. Trade facilitation. With continuous growth in international trade, there was an urgent need for T&T to increase its border capacity as well. The scanning process takes between 2 and 7 minutes! Not only does mobile scanning allow for faster delivery but it also allows for

easier inspection and reduces the manpower requirement in determining the contents of containers.

3. Increased Revenue Collection. The launch of these scanners will certainly mitigate duty and tax fraud and detect undeclared cargo for the collection of duties at the Point Lisas Port.

MANUFACTURERS TO ACCESS U\$D THROUGH EXIMBANK



Empowering exporters for the future

During the 2018 National Budget presentation. the Honourable Colm Imbert. Minister of Finance, proposed the implementation of a US\$100 million facility to be made available for manufacturers, through the Export Import Bank (EXIMBANK), to alleviate the foreign exchange constraints.

This new facility aims to provide foreign exchange access to manufacturers for the purchase of raw materials and other essential inputs for manufacturing.

The facility will be available to "approved" manufacturers and manufacturers who hope to access these funds must be in the business of export. The EXIMBANK guidelines will be published in daily newspapers very soon.

The EXIMBANK has since been granted their licence from the Central Bank of Trinidad and Tobago (CBTT) to trade foreign exchange and the official launch of this service will be held on Friday 4th May, 2018 at the Hyatt Regency Trinidad.
