Tenders are invited for the supply, delivery, installation and commissioning of a fully configurable International Civil Aviation Organization (ICAO) compliant Automated Weather Observing System (AWOS) at the ANR Robinson International Airport for the Meteorological Services Division, Office of the Prime Minister (Tobago Affairs)- Central Administrative Services, Tobago.

A **pre-tender** meeting followed by a site visit will be held for prospective tenderers at the Meteorological Services Division, Crompstain Trace, Store Bay Local Road, Crown Point, Tobago at **10:00 a.m. (local time) on Friday May 18, 2018.**

Tenders must be accompanied by the following:

- (i) Valid Income Tax and Valued Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) A Valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original and five (5) copies of the Tender should be placed in sealed envelopes clearly marked on the outside: -

Tenders will be opened shortly thereafter. The tenderer or an authorized representative may be present at the opening.

Late tenders will not be considered in any circumstances.

The Board does not bind itself to accept the lowest or any other tender.

The Central Tenders Board reserves the right to cancel the bidding process in its entirety or even partially, without defraying any cost incurred by any firm in submitting its tender.
