Tenders are invited for Upgrade of the Wastewater Treatment Plant located at Teteron Barracks, Chaguaramas for the Trinidad and Tobago Defence Force (Regiment), Ministry of National Security.

Tender documents may be obtained during normal working hours from Monday to Friday between 8.00 a.m. and 4.00 p.m. (local time) at the Central Tenders Board's Office, 116 Frederick Street, Port of Spain. Telephone No. 625-3565.

Tenderers are required to pay a tender deposit of Five Hundred Dollars (\$500.00) payable by cash or certified cheque to the Director of Contracts, Central Tenders Board. This deposit will be received from Monday to Friday between the hours of 9.00 a.m. to 12.00 noon and 1.00 p.m. to 3.00p.m. The original receipt must be attached to the tender.

A pre-tender meeting and site visit will be held for prospective tenderers at **10.00 a.m. on Wednesday April 24, 2019** at the Wastewater Treatment Plant, Teteron Barracks, Chaguaramas.

Tenders must be accompanied by the following:

- (i) Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) A Valid Certificate of Compliance issued in accordance with the National Insurance Act.

The original and four (4) copies of the Tender should be placed in sealed envelopes clearly marked on the outside:

"Tender for Upgrade of the Wastewater Treatment Plant located at Teteron Barracks, Chaguaramas for the Trinidad and Tobago Defence Force (Regiment), Ministry of National Security."

Envelopes must be addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain Spain and must be deposited in the BROWN Tenders Box located in the lobby of the Board's Office not later than **1:00 PM ON THURSDAY MAY 09, 2019.**

Tenders will be opened publicly at the Board's Office shortly thereafter. The tenderer or an authorized representative may be present at the opening.

Tenderers should note that the dimensions of the **SLOT** in the Tenders Box are **37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Late tenders **will not** be considered in any circumstances.
