A pre-tender meeting will be held for prospective bidders at **10:00 a.m.** on **Tuesday April 16, 2019** at the Office of the Prime Minister, Gender and Child Affairs, Level 20, Tower D, International Waterfront Centre, 1A Wrightson Road, Port of Spain.

A contract may be awarded for both locations or separate contracts may be awarded for each location.

Tenders must be accompanied by the following:

- (ii) **Valid Income Tax and Value Added Tax Clearance Certificates** issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (iii) **A Valid Certificate of Compliance** issued in accordance with the National Insurance Act.

The original and six (6) copies of the Proposals should be placed in sealed envelopes, addressed to the **Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain** and clearly marked on the outside: -
