Tenderers are required to pay a tender deposit of **One Thousand Dollars (\$1000.00)** payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116 Frederick Street, Port of Spain. This deposit will be received from **Monday to Friday between the hours of 9.00 a.m. to 12.00 noon and 1.00 p.m. to 3.00 p.m.** The original receipt must be attached to the tender.

A pre-tender meeting followed by a site visit will be held for prospective tenderers at **10.00 a.m.** on **Thursday 25th July, 2019** at the Tunapuna/Piarco Regional Corporation Technical Building, Centenary Street, Tunapuna.

Tenders must be accompanied by the following:

- (i) Valid Income Tax and Valued Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
- (ii) A Valid Certificate of Compliance issued in accordance with the National Insurance Act.

The **original and three (3) copies** of the Tender should be placed in sealed envelopes clearly marked on the outside: -
