This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, issue no. IDB36-01/15 of 13 January 2015.

The Government of the Republic of Trinidad and Tobago has received financing from the Inter- American Development Bank (IDB) toward the cost of Health Services Support Program (HSSP), and it intends to apply part of the proceeds of this financing to payments under the Contract for the Procurement of Medical Equipment and Consumables for Lung Cancer Clinic.

The Central Tenders Board (CTB), on behalf of the Permanent Secretary, the Ministry of Health now invites sealed tenders from eligible bidders for the Procurement of Medical Equipment and Consumables for Lung Cancer Clinic.

- ii. Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date for submission of bids. (applicable to local firms only).
- iii. National Insurance Board (NIB) Compliance Certificate issued in accordance with the National Insurance Act (applicable to local firms only).
- iv. Bid Securing Declaration
