Tenders are invited for the Hire of Mechanical Equipment /Vehicles for the Ministry of Works and Transport for a period of two (2) years as follows:-

**Item i** Hire of Mechanical Equipment /Vehicles on an ‘as and when’ required basis for the Ministry of Works and Transport for a period of two (2) years.

**Item ii** Hire of Mechanical Equipment /Vehicles on an ‘as and when’ required basis for **Emergency Works** for the Ministry of Works and Transport for a period of two (2) years.

- (b) **Valid** Certificate of Compliance issued in accordance with the National Insurance Act.

The original and four (4) copies of the tender should be placed in sealed envelopes clearly marked on the outside: -

**Item ii** Hire of Mechanical Equipment /Vehicles on an ‘as and when’ required basis for **Emergency Works** for the Ministry of Works and Transport for a period of two (2) years.
