The Government of the Republic of Trinidad and Tobago has received financing from the Inter-American Development Bank (IDB) toward the cost of Health Services Support Program (HSSP), and it intends to apply part of the proceeds of this financing to payments under the Contract for the Procurement of Physical Activity Equipment for Youth Centers (Phase 2).

The Central Tenders Board (CTB), on behalf of the Permanent Secretary, Ministry of Health now invites sealed tenders from eligible bidders for the Procurement of Physical Activity Equipment for Youth Centers (Phase 2) for the Ministry of Health.

Bidding will be conducted through the International Competitive Bidding procedures as specified in the Inter-American Development Bank's Policies for Procurement of Works and Goods financed by the Inter-American Development Bank (GN 2349-9), and is open to all eligible bidders as defined in the policies which can be found at website: <u>http://www.iadb.org/procurement</u>.

Tenders must be accompanied by the following:-

- i. Valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date for submission of bids. (Applicable to Local Firms only).
- ii. A Valid Certificate of Compliance issued in accordance with the National Insurance Act. (Applicable to Local Firms only).
- iii. Certificate of Incorporation.
- iv. Completed Bid Securing Declaration Form.

The original tender and six (6) copies must be submitted in sealed envelope(s) clearly marked:-
