A pre-tender meeting followed by a site visit will be held for prospective tenderers at **10.00 a.m. on Friday March 05, 2021** at the Staubles Bay Base of the Trinidad and Tobago Coast Guard, Chaguaramas. All attendees are required to wear masks and be compliant of social distancing.

Tenders must be accompanied by valid:

- (i) **Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender. (applicable to local firms)**
- (ii) **Certificate of Compliance issued in accordance with the National Insurance Act. (applicable to local firms)**

The original and four (4) copies of the tender should be placed in sealed envelopes addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and clearly marked on the outside:

“Tender for the Supply, Delivery, Installation and Commissioning of Two (2) Standby Generators Inclusive of Electrical Works for the Trinidad and Tobago Defence Force (Coast Guard), Ministry of National Security.”

Envelopes must be deposited in the **BROWN** Tenders Box located in the lobby of the Board's Office, 116 Frederick Street, Port of Spain not later than **1:00 pm. on Thursday March 18, 2021.**

Tenderers should note that the dimensions of the **SLOT** of the Tenders Box are **37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Tenders will be opened shortly thereafter. The tenderer or an authorized representative may be present at the opening.

Late tenders **will not** be considered in any circumstances.

The Board does not bind itself to accept the lowest or any other tender.

The Central Tenders Board reserves the right to cancel the bidding process in its entirety or even partially, without defraying any cost incurred by any firm in submitting their tender.
