**Tax Amnesty 2021 runs from 5th July 2021 to 17th September, 2021.**

### Taxes Covered Under Tax Amnesty 2021:

- Individual Income Tax
- Pay-As-You-Earn (PAYE)
- Health Surcharge
- Corporation Tax
- Business Levy
- Green Fund Levy
- Value Added Tax (VAT)
- Petroleum Profits Tax (PPT)
- Supplemental Petroleum Tax (SPT)
- Unemployment Levy
- Stamp Duty
- Property Tax (Arrears from Lands & Buildings Taxes and Municipal Corporations Taxes Act, Part V)
- Club Gaming Tax
- Gaming Amusement Tax

### Tax Periods Covered:

- All prior tax periods up to December 31, 2020
- All tax periods which were due and payable during January 01, 2021 to May 31, 2021.

### How to file outstanding tax returns:

- IRD offers two (3) ways in which taxpayers may file returns on e-Tax:
  - (1) Logged in service for taxpayers with ttconnect IDs.
  - (2) Non-logged in service for all taxpayers, especially those without ttconnect IDs can go to:
