Tenders are invited for Construction of Transport Office Building for the Princes Town Regional Corporation, Ministry of Rural Development and Local Government.

Tenderers are required to pay a Tender Deposit of **One Thousand Dollars (\$1000.00)** payable by cash or certified cheque to the Director of Contracts, Central Tenders Board, 116 Frederick Street, Port of Spain. This deposit will be received from Monday to Friday between the hours of **9.00 a.m. to 12:00 noon and 1:00 p.m. to 3:00 p.m.** The **original** receipt must be attached to the tender.

A **site visit/pre-tender meeting** will be held for prospective tenderers at **10.00 a.m.** on **Monday August 8, 2022** at the Transport Compound of the Princes Town Regional Corporation, Railway Road, Princes Town.

Tenders must be accompanied by the following:

- (ii) **Valid Income Tax and Valued Added Tax Clearance Certificates** issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender. (Applicable to local firms only)
- (iii) **A Valid Certificate of Compliance** issued in accordance with the National Insurance Act. (Applicable to local firms only)

The original and three (3) copies of the Tender should be placed in sealed envelopes, addressed to the **Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain** and clearly marked on the outside: -

“Tender for Construction of Transport Office Building for the Princes Town Regional Corporation, Ministry of Rural Development and Local Government”

Envelopes must be deposited in the **BROWN** Tenders Box, located in the lobby of the Board's Office, 116 Frederick Street, Port of Spain, not later than **1:00 p.m.** on **THURSDAY August 18, 2022.**

Tenderers should note that the dimensions of the **SLOT** in the Tenders Box are **37.5 cm x 5.5 cm** and as such, tenders should be packaged accordingly.

Tenders will be opened publicly at the Board's Office shortly thereafter. The tenderer or an authorized representative may be present at the opening.

Late tenders **will not** be considered in any circumstances.

The Board does not bind itself to accept the lowest or any other tender.

The Central Tenders Board reserves the right to cancel the bidding process in its entirety or partially, without defraying any cost incurred by any firm in submitting their tender.
