The Tax Amnesty provides a waiver on the Penalties and Interest for returns and taxes for the following:

- To make payment, you will need a Payment Description Slip (PDS). To save time at the IRD offices, you can generate a PDS via the IRD's e-Tax platform at <https://etax.ird.gov.tt/>
- Online Payments of \$100,000.00 to \$499,999.99 can be made via ACH and via safeTT for over \$500,000.00 through the Central Bank of Trinidad and Tobago (CBTT).
