- (ii) **Certificate of Compliance issued in accordance with the National Insurance Act. (applicable to local firms only)**

The original and two (2) copies of the tender should be placed in sealed envelopes addressed to the Chairman, Central Tenders Board, 116 Frederick Street, Port of Spain and clearly marked on the outside:
