MADE BY THE MINISTER UNDER SECTION 13(2) OF THE EXCISE
(GENERAL PROVISIONS) ACTTHE EXCISE DUTY (ALCOHOLIC BEVERAGES) (AMENDMENT)
(NO. 2) ORDER, 2025

1. This Order may be cited as the Excise Duty (Alcoholic Beverages) (Amendment) (No. 2) Order, 2025. Citation

2. The Excise Duty (Alcoholic Beverages) Order is amended in clause 2 by deleting the Excise Duty set out in the Third Column which correspond to the Tariff Heading Number and Product set out in the First and Second Columns respectively, and substituting the following new Excise Duty: Legal Notice
